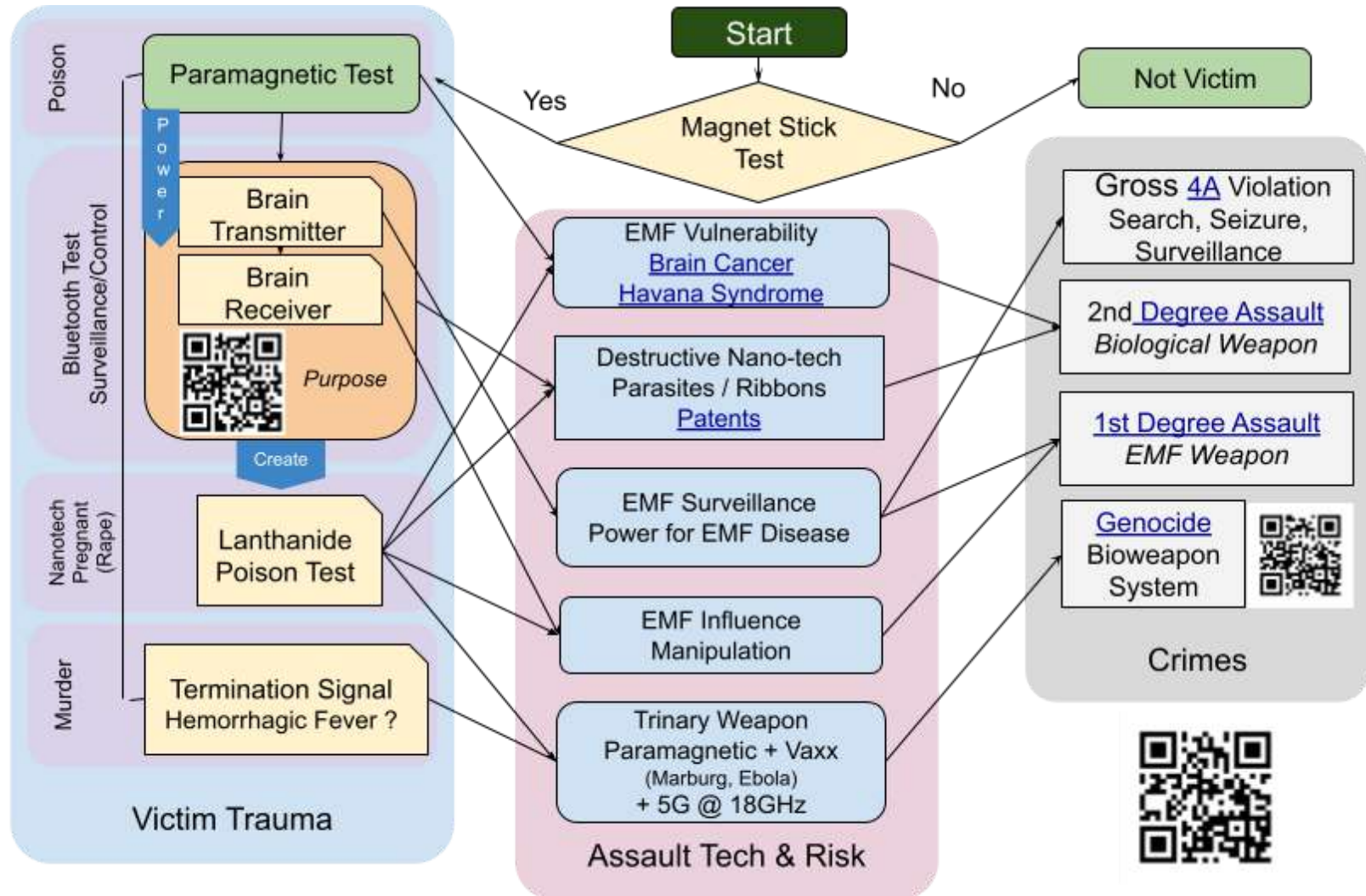

EMF Test Instructions

<p>Magnet Stick Test - Lightly press a neodymium refrigerator magnet to different parts of the forehead. If it sticks anywhere, the result is positive. The victim has been poisoned with super-paramagnetic material.</p>	<p>Magnet Survey</p>
<p>Brain Transmitter Test - Turn on power meter, press RF button (mW/m2), hold meter to forehead, top, sides, then back of head. If the meter beeps, the test is positive. Record the mW/m2 value. This measures the degree of nanotech infiltration in the person's head. Higher numbers indicate more intense transmission from the victim. Bluetooth Signal Shield Removal Test

This test requires a small piece of shield fabric and a bluetooth MAC address detector application.

1. Secure all bluetooth devices a reasonable distance from the test area.
2. Cover Subject with Shield Fabric. Shielding blocks the subject from receiving external magnetic fields from LAN, 5G and other sources.
3. Wait 3 minutes to power-down devices in subject. Internal MAC devices use "stray" fields, this blocks the power supply to these devices so they stop transmitting. The shield also blocks emissions. This combination removes any nano-tech devices from being detected.
4. Start a bluetooth detector device. Clear all lists. Turn on Bluetooth Address sensor and let Bluetooth detector device initialize for 3 minutes to detect local Mac Addresses. Save list if application permits. At this point the detector device is aware of all devices except those from those coming from the subject.
5. Remove Shield fabric from the subject. This restores EMF signal to the subject and stops blocking signals from the subject.
6. Watch list for 3 minutes for appearance of new Bluetooth MAC addresses. These addresses will be "unknown" and will not be associated with any licensed application. Signals from these devices are delayed because they need to absorb environmental EMF to gain power to power up. Multiply vaccinated individuals may have multiple MAC addresses.
7. Record any MAC addresses that appeared after the shield was removed. These are coming from the subject

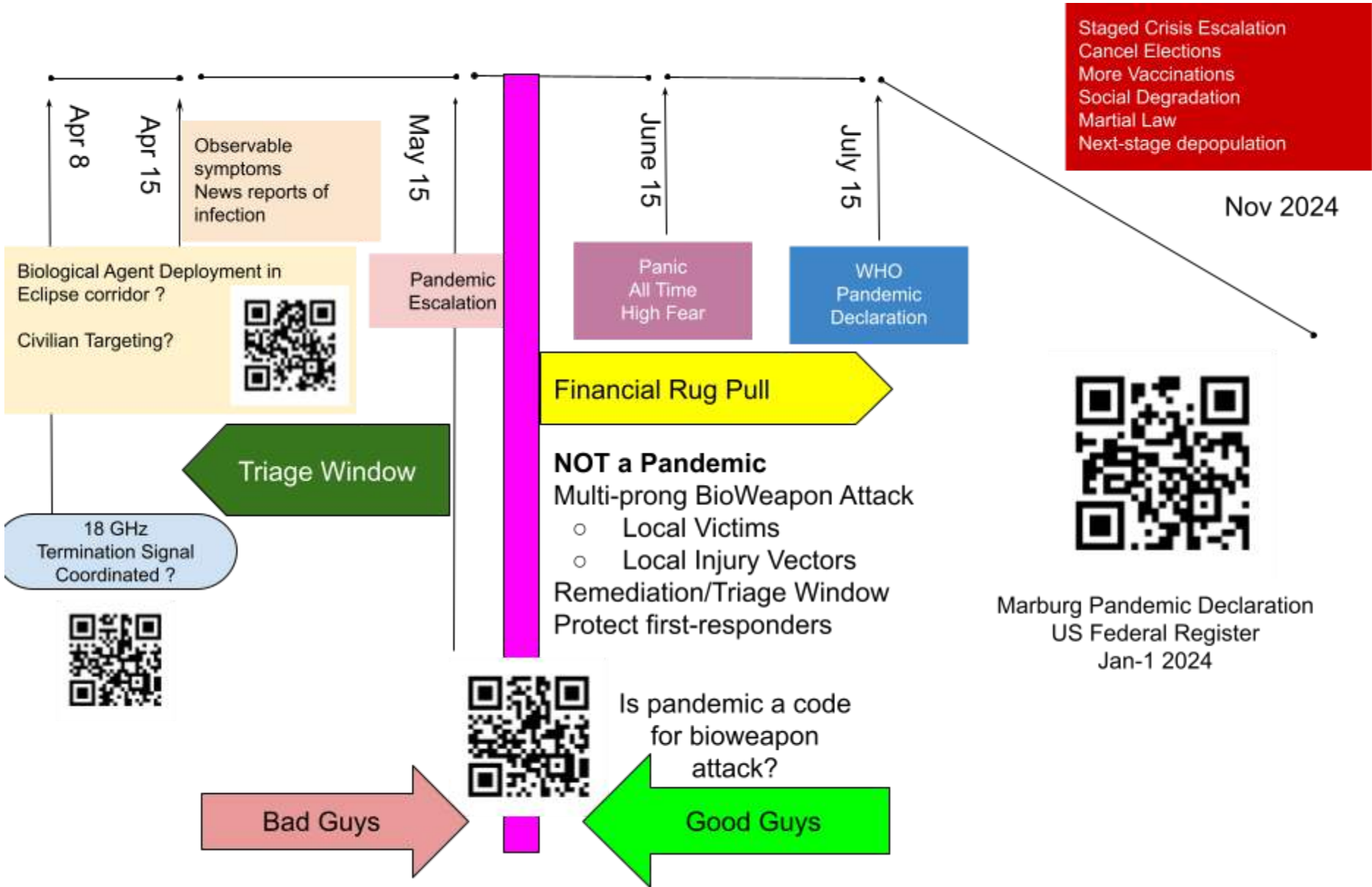
Phase 6: Cancel the debts and dematerialize the money. (March 2022-September 2022)

Compliance Statement

This crime report is submitted pursuant and in compliance with: Duty to report a crime - liability for disclosure [CRS 18-8-115](#)

It is the duty of every corporation or person who has reasonable grounds to believe that a crime has been committed to report promptly the suspected crime to law enforcement authorities. Notwithstanding any other provision of the law to the contrary, a corporation or person may disclose information concerning a suspected crime to other persons or corporations for the purpose of giving notice of the possibility that other such criminal conduct may be attempted which may affect the persons or corporations notified. When acting in good faith, such corporation or person shall be immune from any civil liability for such reporting or disclosure. This duty shall exist notwithstanding any other provision of the law to the contrary; except that this section shall not require disclosure of any communication privileged by law.

Strategy

1. Establish the investigator as a personal stakeholder (victim) in the crime(s);
2. Empower investigator to use simple devices to validate and corroborate evidence with as victim identification kit:
 - a. **Magnet** to confirm paramagnetic poisoning
 - b. **RF power Meter** to confirm integration of RF transmission into victim;
 - c. **RF shielding** to confirm integration of RF reception into victim;
3. Guide investigator to realize broad crime scope of the crime by testing peers in law enforcement;
4. Guide investigator to realize existential risk to life, family and community to nanotechnology deployed by injection, food, and water per Callender Disclosure injected as "COVID Vaccines".
5. Trigger triage & remediation in time to protect critical local infrastructure with initial focus on first responders, scaling to protect community members;
6. Make it clear to first responders that so-called pandemics are premeditated and staged bioweapon attacks to enable effective and timely response to protect life.

Exhibits & Evidence Tests

- E-1-a: N-40 Neodymium Magnet
- E-1-b: Mirror or Cell phone
- E-1-c: EMF Signal Meter
- E-1-d: Bluetooth Address Survey device
- E-1-e: Peace officer(s) with magnet(s) sticking to forehead

Evidence of Magnetic poisoning of humans:

E-1-a adheres E-1-e: Human tissue from any law enforcement official, firefighter, health care worker or student now present.

Now place **E-1-a (magnet)**, the magnet, upon the forehead of **E-1-e (peace officer)**. If it sticks this is evidence of magnetism that subject E-1-e has consumed a sufficient quantity of poison material to cause the person to exhibit anomalous magnetic phenomena. The form and route(s) of administration are unknown. This evidence is blatant.

This person is a poisoning victim. The person's body contains a sufficient amount of super paramagnetic contaminant to elevate harm from exposure to electromagnetic signals and exhibit termination response to lower amplitude broadcast 18 GHz signals.

Sticking is evidence that the victim was poisoned by consumption of food items, **E-2-a, E-2-b, and E-2-c**, by intentional introduction of contaminants, upstream in the food-supply chain, or as an injected medication.



Other anomalous evidence of harm to humans

This evidence is easily observable with a microscope to view blood.

They should implement remediation and avoidance or shielding from electromagnetic radiation.

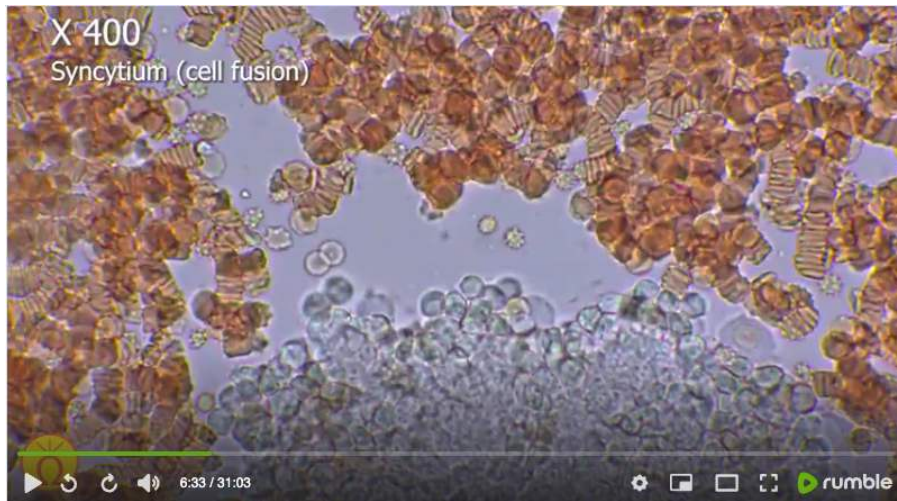

Magnetic contamination in food

Magnetic contamination in meat from local sources, particularly poultry, pork and chicken, were easily observed until January 8, 2024. At this time, all conventionally raised chicken, beef and pork has been removed from the shelves at local stores. No paramagnetic samples were available in Laporte, King Soopers, or North Fort Collins Walmart.

Only organic products remain in stock.

Prior to the check on January 8, it was easy to find contaminated meat. Initial testing was conducted during about November of 2023 at King Soopers, and Overland foods in Laporte, Colorado.

E-1-a stick to E-2-a, E-2-b, E-2-c: Meat samples obtained from Walmart, 4500 Weitzel St, Timnath, CO 80547. Note that the magnet are three magnetic samples: beef, chicken and pork, and a control sample from another store which did not test magnetic.

Sticking the magnet, Exhibit-2, to Exhibit-1 clearly evidences the food products obtained from King Soopers contain contaminants that change the electromagnetic properties of the meats. Approximately 30% of meat products contain enough contaminants to cause magnets to stick.





The meat products are contaminated with unnatural substances causing them to be magnetically active.

3 one minute signals @ 18 GHz.

A *Victim Termination Signal Kit* is offered as evidence. The kit can be used either to remediate, slow-release alleged Marburg toxins, or to quick-release, per Callender disclosure.

Triage

1. A process for sorting injured people into groups based on their need for or likely benefit from immediate medical treatment. Triage is used in hospital emergency rooms, on battlefields, and at disaster sites when limited medical resources must be allocated.
2. A system used to allocate a scarce commodity, such as food, only to those capable of deriving the greatest benefit from it.
3. A process in which things are ranked in terms of importance or priority.

First Objective - Buy Time

The 4G system, and 5G LTe infrastructure operates below 10 GHz and appears safe. This means that most active cell phone infrastructure does not pose an immediate threat.

High frequency infrastructure, above 10 GHz, is primarily deployed in dense population areas, Fort Collins, Loveland and Greeley, based on coverage maps from ATT & Verizon. Usage is unknown, but the majority of the communications infrastructure could remain operable.

Depowering the high frequency transmitters would negate the ability for these systems to broadcast an 18 GHz signal.

This neutralizes harm potential until the threat can be investigated and the vulnerability neutralized.

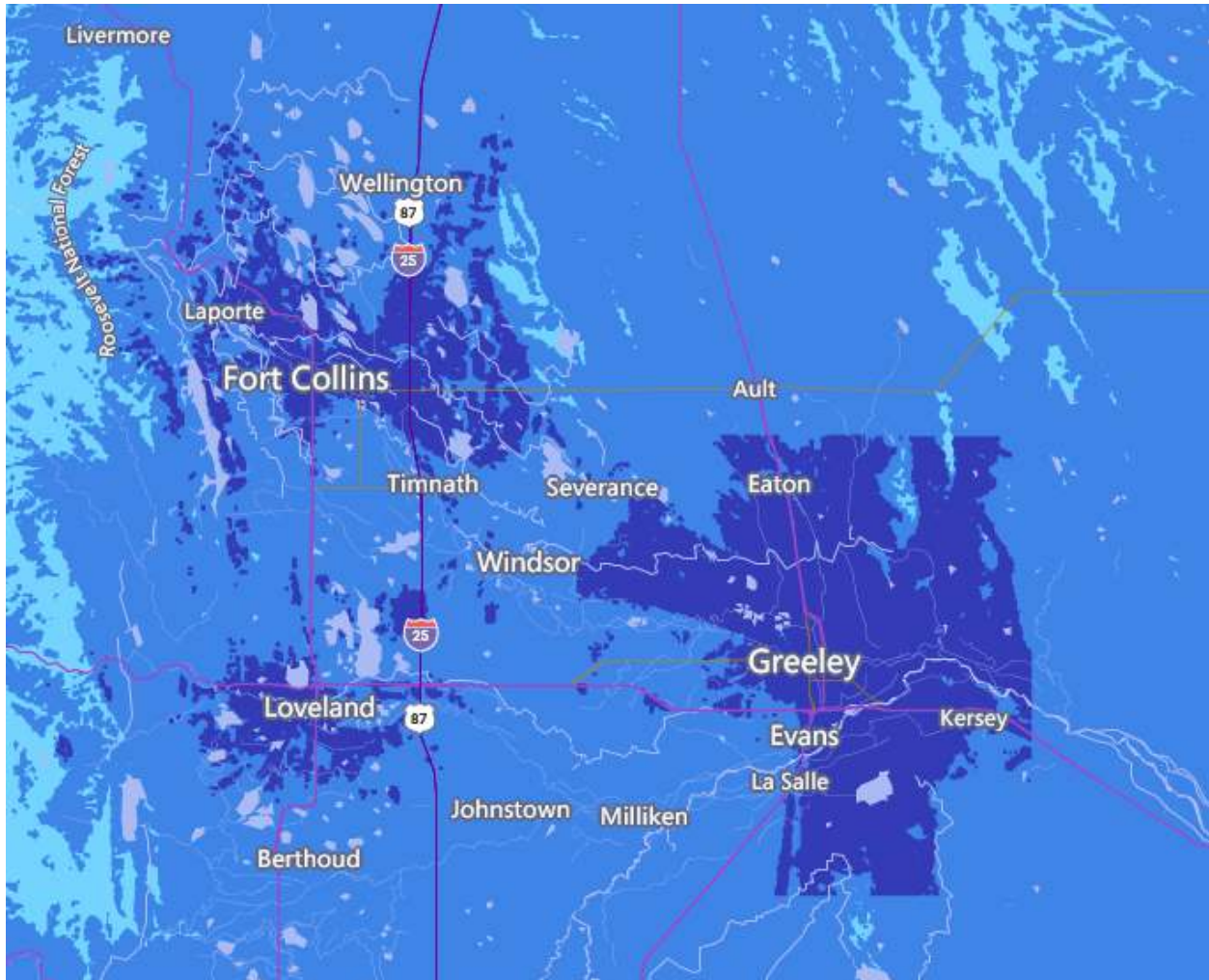
EMF Attack Risk Map

Because their continued operation is a risk to life and limb to police, first responders, and the general public, refusal of the operators to shut these systems down asserts the operators intend to harm the public.

Second Triage Objective - Protect First Responders

Recommended Triage Priority:

1. Vaccinated first responders & police
2. Unvaccinated first responders & police

When the termination signal is broadcast, all of the vaccinated individuals will become ill. Loss of vaccinated first responders will decimate social infrastructure and ability to have functional support for the general population.

The Marburg NanoLipid packets represent the immediate threat to life. The protocol is designed to neutralize these spreads 18 GHz exposure over a large amount of time.

Victims may also experience [1P36 gene deletion syndrome](#) which causes severe mental retardation from shrinkage of the prefrontal cortex.

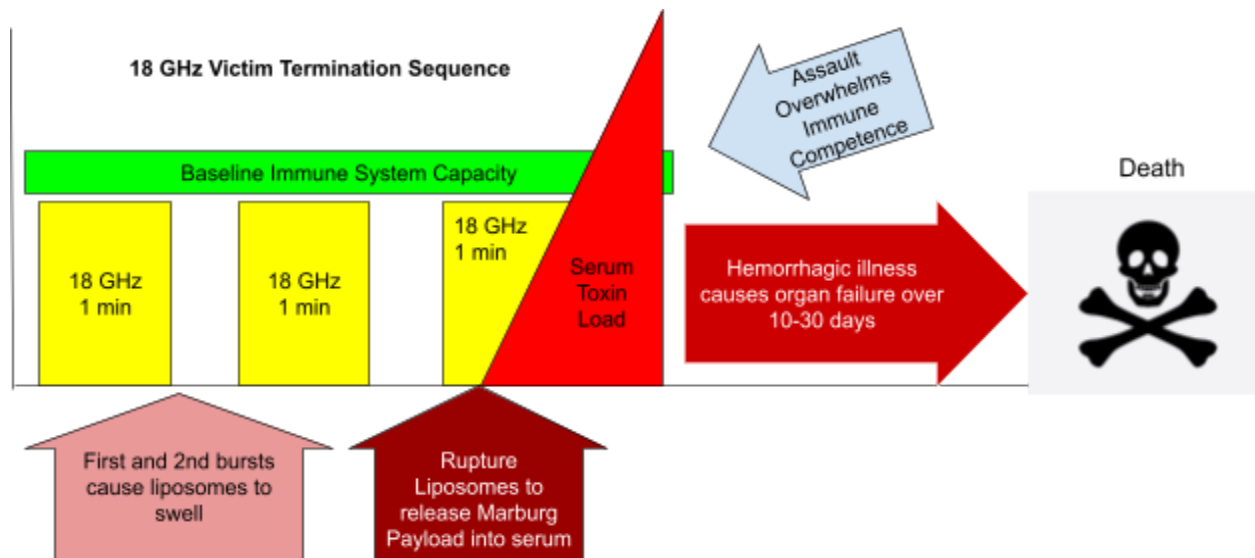

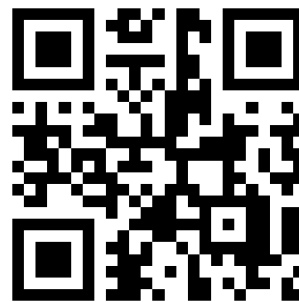

This image illustrates the apparent physiological scenario triggered by the **victim terminal signal**.

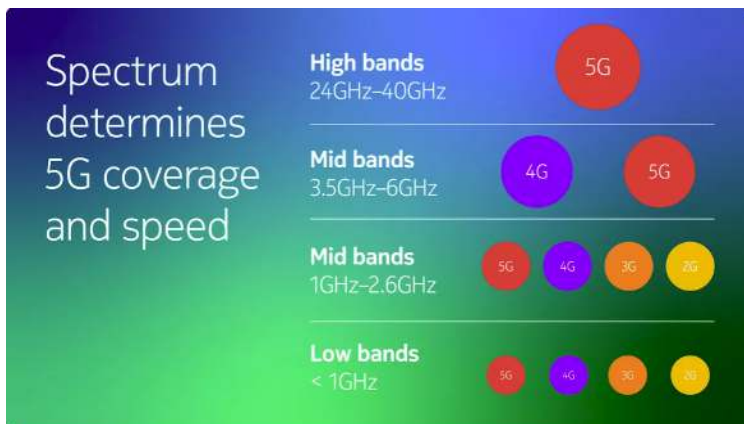

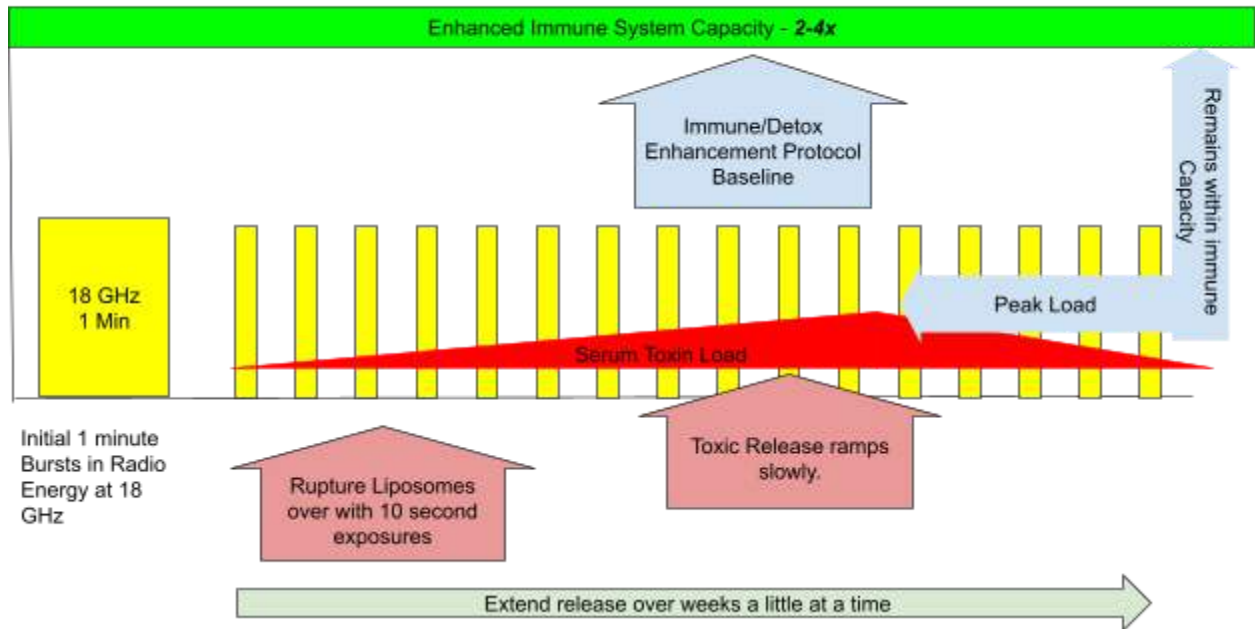

Victim Options

At the time of this writing there is no evidence that a termination signal has been broadcast.

The final signal triggers liposome rupture to cause a burst release of the toxin payload into the victim's blood.

The Victim Signal Termination Kit evidence kit creates three options:

Death Risk to Larimer County Personnel

Since a **Victim Termination Signal** may be transmitted from standard telecommunications equipment, vaccinated occupants of all government facilities near 18 GHz radio transmission equipment may be at risk.

This includes, but is not limited to Larimer County within range of 5G towers capable of transmission of 18GHz signals:

- Sheriff Department;
- Office Personnel;
- Firefighters, Healthcare workers, and emergency responders.

5G Capable Cell Phones

Recent generation cell phones are capable of frequencies up to 40 GHz. This means any iPhone or Android app may be able to broadcast a **Victim Termination Signal**.

5G Cell Towers

Modern cell towers reportedly have enough power capacity, and phased array capacity to broadcast powerful signals at a distance. High frequency cell towers can broadcast a **Victim Termination Signal** to a region affecting a target group, like a police station - thus neutralizing vaccinated PERSONNEL.

Portable Microwave Systems

Individuals can purchase high frequency generators and transmitters off the shelf. They are legal and not considered dangerous because they are used in many communication applications.

This means any party who builds a directional signal generator, sets it to 18 GHz, and points it at a building with vaccinated people will broadcast the **Victim Termination Signal**.

1. Microwave oven

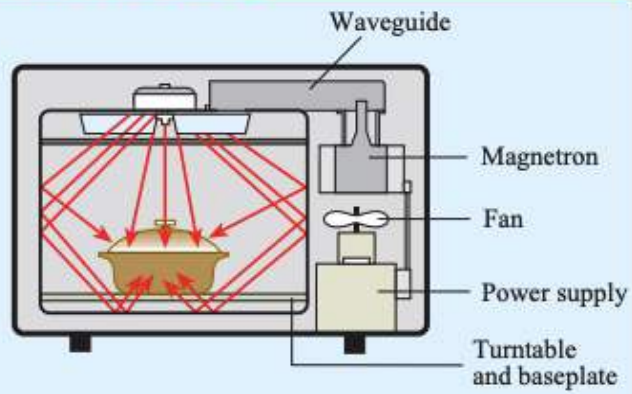


Figure 1. Schematic diagram of a typical microwave oven.

Weapon System

This is a 3 part weapon system including at least 3 integrated systems:

1. Radio Sensitizing Toxins in food and other sources
2. Lipid nanoparticle encapsulated disease agents administered by injection

Recognizing symptoms of poisoning:

Relationship and coordinated effect of harmful technologies:

Victims

There are three categories of victim:

- An *assault victim* is any person who exhibits one or more forms of injury resulting from the delivery of poisons formulated, manufactured and distributed by perpetrators;
- A *murder victim* is any person who died as a consequence of exposure to any poison who lacked informed consent by ingesting or by injection as articulated in the Nuremberg Code and incorporated into statutes.
- An *extortion victim* is any person who was coerced to accept any medication as or under threat of deprivation of any right or privilege such as a condition of employment, attendance at any school, or participation in any social activity.

Victims include peace officers, firefighters, emergency medical service providers, judiciary officers, making most perpetrators subject to severe penalties. Victims include children, law enforcement and prosecution are encouraged to pursue the harshest punishment of perpetrators defined by law.

Observation of any combination of these effects constitutes evidence that one or more **perpetrators** committed one or more crimes. Some perpetrators acted with malicious intent to commit genocide.

Other committed harmful acts unknowingly, like healthcare providers that administered injections containing poison under the belief it was for the benefit of the recipient. It is important to identify those who gave injections to others but didn't take them.

A perpetrator is any person who took any intentional or unintentional action which caused a person to be a victim.

Federal waivers of liability for vaccines do not create immunity from any state law.

Victim Identification

- Numerous peace officers, judicial officers, public officials,
- Children and adults in Larimer County.

Perpetrator Identification

- Accomplices
- Manslaughter: Doctors, Hospitals
- Murder and Assault: Food Suppliers, Pharmaceutical Manufacturers, Medical officials, and others who knowingly participated in the crimes;
- Criminal Extortion: School Board and Public Officials who used threat or hardship to coerce others in violation of statutes that embody the Nuremberg Code.

Applicable Statutes

Any person who has died as a direct or indirect result of poisoning and subsequent exposure to electromagnetic radiation.

The crimes herein described have adversely affected persons, peace officers, firefighters, health care providers, children and adults in Larimer County. These crimes were allowed to occur because public officials have failed or in many cases refused to perform the duties. duties.

These serious crimes adversely affected residents of Larimer County due to elected and appointed officials habitually failing to perform their duties.

As remedy any elected or appointed official, with duties to enforce, prosecute the law as written must do their job.

Oath of Office

Colorado statutes require an Oath of Office. As such each official is required to swear and in most cases file a written promise to uphold the United States and Colorado Constitution.

[The Colorado Laws were amended in 2018](#). Any person occupying an office lacking an oath of office is guilty of impersonating a public official, a [class 2 misdemeanor](#).

It is the duty of law enforcement to remove any person who is impersonating a public official from office. Any law enforcement official who permits an impersonator becomes a co-conspirator (reference required)

Public Official Impersonators that Participate in greater crimes

When an official's misdemeanor act enables a greater crime pursuant to [18 U.S.C 96 RICO Statutes](#), then the public official may be deemed a co-conspirator, and thus become subject to the penalties of the greater crime. RICO statutes include murder as a serious crime.

When the actions of an impersonator enable a murder by due to failure to act, performance of a lesser crime, the impersonator is a participant in the serious crime. The nature and degree of guilt is a matter for the courts to decide.

When the impersonation public official enables murder, then the impersonator may be charged with murder if their actions led to wrongful death, provided any other co-conspirator intended to murder a victim.

Peace Officers, including the sheriff are obliged to have a valid oath of office. Any person acting as a peace officer who lacks an oath of office is guilty of a Class 6 felony pursuant to C.R.S 18-8-112.

§ 24-12-101. Form of oath or affirmation for public office - requirements for oath or affirmation

(1) When a person is required to take an oath or affirmation before the person enters upon the discharge of a public office or position, the form of the oath or affirmation is as follows:

I [name], do [select swear, affirm, or swear by the everliving God] that I will support the constitution of the United States, the constitution of the state of Colorado, and the laws of the state of Colorado, and will faithfully perform the duties of the office of [name of office or position] upon which I am about to enter to the best of my ability.

I [name], do [select swear, affirm, or swear by the everliving God] that I will support the constitution of the United States, the constitution of the state of Colorado, and the laws of the state of Colorado, and will faithfully perform the duties of the office of [name of office or position] upon which I am about to enter to the best of my ability. If choosing to swear an oath, the person swearing shall do so with an uplifted hand.

(2) The oath or affirmation must be:

- (a) In writing and signed by the person taking the oath or affirmation;
- (b) Administered as provided in section 24-12-103; and
- (c) Taken, signed, administered, and filed as specified in subsection (3) of this section before the person enters upon the public office or position.

(3) Officers of the executive department, judges of the supreme and subsidiary courts, and district attorneys shall file their oaths or affirmations of office with the secretary of state. Every other person required by law to file an oath or affirmation of office shall file with the county clerk of the county wherein the person was elected or appointed.

§ 20-1-101. Bond and oath of district attorney and staff

Universal Citation: CO Rev Stat § 20-1-101 (2016)

(1) Every district attorney, before entering upon the duties of his office, shall take and subscribe an oath to support the constitution of the United States and the organic law of the state and that he will faithfully discharge the duties of his office. He shall also execute to the people of the state of Colorado a bond in the sum of five thousand dollars, with a good and sufficient individual, schedule, or blanket corporate surety bond, or other acceptable security, to be approved by the

secretary of state, conditioned for the faithful discharge of the duties of his office, as the same are prescribed by law, and upon any breach of such bond, an action shall lie thereon for the benefit of any county fund or person injured thereby.

(2) As the district attorney may direct, the assistant and deputy district attorneys and other employees appointed pursuant to this title may be required to file with the secretary of state the bond required by law to be filed by district attorneys.

[Impersonating a public servant](#)

(1) A person commits impersonating a public servant if he falsely pretends to be a public servant other than a peace officer and performs any act in that pretended capacity.

(2) It is no defense to a prosecution under this section that the office the actor pretended to hold did not in fact exist.

(3) Impersonating a public servant is a class 3 misdemeanor.

(3) Impersonating a public servant is a class 2 misdemeanor.

[§ 18-8-112. Impersonating a peace officer](#)

Universal Citation: [CO Rev Stat § 18-8-112 \(2016\)](#)

(1) A person who falsely pretends to be a peace officer and performs an act in that pretended capacity commits impersonating a peace officer.

(2) Impersonating a peace officer is a class 6 felony.

Colorado Revised Statutes Title 18. Criminal Code § 18-2-201.

Conspiracy

Current as of January 01, 2022 | Updated by [FindLaw Staff](#)

(1) A person commits conspiracy to commit a crime if, with the intent to promote or facilitate its commission, he agrees with another person or persons that they, or one or more of them, will engage in conduct which constitutes a crime or an attempt to commit a crime, or he agrees to aid the other person or persons in the planning or commission of a crime or of an attempt to commit such crime.

(2) No person may be convicted of conspiracy to commit a crime, unless an overt act in pursuance of that conspiracy is proved to have been done by him or by a person with whom he conspired.

(3) If a person knows that one with whom he conspires to commit a crime has conspired with another person or persons to commit the same crime, he is guilty of conspiring to commit a crime with the other person or persons, whether or not he knows their identity.

(4) If a person conspires to commit a number of crimes, he is guilty of only one conspiracy so long as such multiple crimes are part of a single criminal episode.

(4.5) Conspiracy to commit any crime for which a court is required to sentence a defendant for a crime of violence in accordance with [section 18-1.3-406](#) is itself a crime of violence for the purposes of that section.

<Text of (5) effective until March 1, 2022>

(5) If a person conspires to commit a felony which is defined by any statute other than one contained in this title and for which conspiracy no penalty is specifically provided, he is guilty of a class 6 felony. If a person conspires to commit a misdemeanor which is defined by any statute other than one contained in this title and for which conspiracy no penalty is specifically provided, he is guilty of a class 3 misdemeanor.

<Text of (5) effective March 1, 2022>

(5) If a person conspires to commit a felony which is defined by any statute other than one contained in this title and for which conspiracy no penalty is specifically provided, the person commits a class 6 felony. If a person conspires to commit a misdemeanor which is defined by any statute other than one contained in this title and for which conspiracy no penalty is specifically provided, the person commits a class 2 misdemeanor.

§ 18-1-603. Complicity

Universal Citation: [CO Rev Stat § 18-1-603 \(2016\)](#)

A person is legally accountable as principal for the behavior of another constituting a criminal offense if, with the intent to promote or facilitate the commission of the offense, he or she aids, abets, advises, or encourages the other person in planning or committing the offense.

Murder in the first degree, 18-2-102

(1) A person commits the crime of murder in the first degree if:

(a) After deliberation and with the intent to cause the death of a person other than himself, he causes the death of that person or of another person; or

(b) Acting either alone or with one or more persons, he or she commits or attempts to commit arson, robbery, burglary, kidnapping, sexual assault as prohibited by section 18-3-402, sexual assault in the first or second degree as prohibited by section 18-3-402 or 18-3-403 as those sections existed prior to July 1, 2000, or a class 3 felony for sexual

assault on a child as provided in section 18-3-405 (2), or the crime of escape as provided in section 18-8-208, and, in the course of or in furtherance of the crime that he or she is committing or attempting to commit, or of immediate flight therefrom, the death of a person, other than one of the participants, is caused by anyone; or

(c) By perjury or subornation of perjury he procures the conviction and execution of any innocent person; or

(d) Under circumstances evidencing an attitude of universal malice manifesting extreme indifference to the value of human life generally, he knowingly engages in conduct which creates a grave risk of death to a person, or persons, other than himself, and thereby causes the death of another; or

(e) He or she commits unlawful distribution, dispensation, or sale of a controlled substance to a person under the age of eighteen years on school grounds as provided in section 18-18-407 (2), and the death of such person is caused by the use of such controlled substance; or

(f) The person knowingly causes the death of a child who has not yet attained twelve years of age and the person committing the offense is one in a position of trust with respect to the victim.

Victim Identification:

- Any person who dies subsequent to exposure to 3 one minute pulses of electromagnetic radiation at 18 GHz.
- Any person who has died as a direct or indirect result of poisoning and subsequent exposure to electromagnetic radiation.
- Any person who dies as a result of myocarditis, stroke, or vascular occlusion, which upon autopsy shows existence of unnatural rubbery artifacts in the vascular system

Assault in the First Degree [18-3-202](#), second degree [18-3-203](#),

[\(1\) A person commits the crime of assault in the first degree if:](#)

[\(a\) With intent to cause serious bodily injury to another person, he causes serious bodily injury to any person by means of a deadly weapon; or](#)

[\(b\) With intent to disfigure another person seriously and permanently, or to destroy, amputate, or disable permanently a member or organ of his body, he causes such an injury to any person; or](#)

[\(c\) Under circumstances manifesting extreme indifference to the value of human life, he knowingly engages in conduct which creates a grave risk of death to another person, and thereby causes serious bodily injury to any person; or](#)

[\(d\) Repealed.](#)

(e) With intent to cause serious bodily injury upon the person of a peace officer, firefighter, or emergency medical service provider, he or she threatens with a deadly weapon a peace officer, firefighter, or emergency medical service provider engaged in the performance of his or her duties, and the offender knows or reasonably should know that the victim is a peace officer, firefighter, or emergency medical service provider acting in the performance of his or her duties; or

(e.5) With intent to cause serious bodily injury upon the person of a judge of a court of competent jurisdiction or an officer of said court, he threatens with a deadly weapon a judge of a court of competent jurisdiction or an officer of said court, and the offender knows or reasonably should know that the victim is a judge of a court of competent jurisdiction or an officer of said court;

Victim Identification:

- Any person who becomes physically or mentally impaired subsequent to exposure to any vaccine;
- Any vaccinated person who develops Marburg, Dengue or Ebola like symptoms subsequent to exposure to 3 one minute pulses of electromagnetic radiation at 18 GHz;
- Any person who develops any cardiovascular injury or loss of function resulting from formation of rubber-like artifacts in the vascular system.

Manslaughter 18-3-104

1. A person commits the crime of manslaughter if:
 1. Such person recklessly causes the death of another person; or
 2. Such person intentionally causes or aids another person to commit suicide.
 3. (Deleted by amendment, L. 96, p. 1844 , § 13, effective July 1, 1996.)
2. Manslaughter is a class 4 felony.
3. This section shall not apply to a person, including a proxy decision-maker as such person is described in section 15-18.5-103, C.R.S., who complies with any advance medical directive in accordance with the provisions of title 15, C.R.S., including a medical durable power of attorney, a living will, or a cardiopulmonary resuscitation (CPR) directive.
 1. This section shall not apply to a medical caregiver with prescriptive authority or authority to administer medication who prescribes or administers medication for palliative care to a terminally ill patient with the consent of the terminally ill patient or his or her agent.
 2. For purposes of this subsection (4):
 1. "Agent" means a person appointed to represent the interests of the terminally ill patient by a medical power of attorney, power of attorney, health-care proxy, or any other similar statutory or regular procedure used for designation of such person.
 2. "Medical caregiver" means a physician, registered nurse, nurse practitioner, physician assistant, or anesthesiologist assistant licensed by this state.
 3. "Palliative care" means medical care and treatment provided by a licensed medical caregiver to a patient with an advanced chronic or terminal illness whose condition may not be responsive to curative

- treatment and who is, therefore, receiving treatment that relieves pain and suffering and supports the best possible quality of his or her life.
3. Paragraph (a) of this subsection (4) shall not be interpreted to permit a medical caregiver to assist in the suicide of the patient.

Criminal extortion - aggravated extortion [18-23-207](#)

(1) A person commits criminal extortion if:

(a) The person, without legal authority and with the intent to induce another person against that other person's will to perform an act or to refrain from performing a lawful act, makes a substantial threat to confine or restrain, cause economic hardship or bodily injury to, or damage the property or reputation of, the threatened person or another person; and

(b) The person threatens to cause the results described in paragraph (a) of this subsection (1) by:

(I) Performing or causing an unlawful act to be performed; or

(II) Invoking action by a third party, including but not limited to, the state or any of its political subdivisions, whose interests are not substantially related to the interests pursued by the person making the threat.

(1.5) A person commits criminal extortion if the person, with the intent to induce another person against that other person's will to give the person money or another item of value, threatens to report to law enforcement officials the immigration status of the threatened person or another person.

(2) A person commits aggravated criminal extortion if, in addition to the acts described in subsection (1) of this section, the person threatens to cause the results described in paragraph (a) of subsection (1) of this section by means of chemical, biological, or harmful radioactive agents, weapons, or poison.

(3) For the purposes of this section, "substantial threat" means a threat that is reasonably likely to induce a belief that the threat will be carried out and is one that threatens that significant confinement, restraint, injury, or damage will occur.

(4) Criminal extortion, as described in subsections (1) and (1.5) of this section, is a class 4 felony. Aggravated criminal extortion, as described in subsection (2) of this section, is a class 3 felony.

Victim Identification:

- Any person who took a vaccine as a condition of employment;
- Any person coerced to take a vaccine as a condition to attend an educational institution;

- If the person who took the a vaccine was injured the person who coerced them may be guilty of assault;
- If the person who took a vaccine died, then the person who coerced them may be guilty of manslaughter, homicide or murder.

Reckless endangerment [18-3-208](#)

A person who recklessly engages in conduct which creates a substantial risk of serious bodily injury to another person commits reckless endangerment, which is a class 3 misdemeanor.

The Nuremberg Code - Informed Consent

The statute for Criminal Extortion embodies the Nuremberg Code requirements for informed consent. Any person who coerced another person(s) under threat of economic hardship, accepting an injection as a condition of employment, to accept any injection against their will are guilty of [Criminal Extortion pursuant to 18-3-207](#), a class 4 felony. This statute embodies the universal prohibitions by the threat of economic hardship to subvert informed consent as set forth in the Nuremberg Code:

- a. The voluntary consent of the human subject is absolutely essential. This means that the person involved should have legal capacity to give consent; should be so situated as to be able to exercise free power of choice, without the intervention of any element of force, fraud, deceit, duress, overreaching, or other ulterior form of constraint or coercion; and should have sufficient knowledge and comprehension of the elements of the subject matter involved as to enable him to make an understanding and enlightened decision. This latter element requires that before the acceptance of an affirmative decision by the experimental subject there should be made known to him the nature, duration, and purpose of the experiment; the method and means by which it is to be conducted; all inconveniences and hazards reasonably to be expected; and the effects upon his health or person which may possibly come from his participation in the experiment.
- b. The duty and responsibility for ascertaining the quality of the consent rests upon each individual who initiates, directs, or engages in the experiment. It is a personal duty and responsibility which may not be delegated to another with impunity.

§ 18-1-607. Criminal liability of an individual for corporate conduct

Universal Citation: [CO Rev Stat § 18-1-607 \(2016\)](#)

A person is criminally liable for conduct constituting an offense which he performs or causes to occur in the name of or in behalf of a corporation to the same extent as if that conduct were performed or caused by him in his own name or behalf.

§ 18-1-606. Criminal liability of business entities

Universal Citation: [CO Rev Stat § 18-1-606 \(2016\)](#)

(1) A business entity is guilty of an offense if:

(a) The conduct constituting the offense consists of an omission to discharge a specific duty of affirmative performance imposed on the business entity by law; or

(b) The conduct constituting the offense is engaged in, authorized, solicited, requested, commanded, or knowingly tolerated by the governing body or individual authorized to manage the affairs of the business entity or by a high managerial agent acting within the scope of his or her employment or in behalf of the business entity.

(2) As used in this section:

(a) "Agent" means any director, officer, or employee of a business entity, or any other person who is authorized to act in behalf of the business entity, and "high managerial agent" means an officer of a business entity or any other agent in a position of comparable authority with respect to the formulation of the business entity's policy or the supervision in a managerial capacity of subordinate employees.

(b) "Business entity" means a corporation or other entity that is subject to the provisions of title 7, C.R.S.; foreign corporations qualified to do business in this state pursuant to article 115 of title 7, C.R.S., specifically including federally chartered or authorized financial institutions; a corporation or other entity that is subject to the provisions of title 11, C.R.S.; or a sole proprietorship or other association or group of individuals doing business in the state.

(3) Every offense committed by a corporation prior to July 1, 1985, which would be a felony if committed by an individual shall subject the corporation to the payment of a fine of not less than one thousand dollars nor more than fifteen thousand dollars. For such offenses committed on or after July 1, 1985, the corporation shall be subject to the payment of a fine within the presumptive ranges authorized by section 18-1.3-401 (1) (a) (III). Every offense committed by a corporation which would be a misdemeanor or petty

offense if committed by an individual shall subject the corporation to the payment of a fine within the minimum and maximum fines authorized by sections 18-1.3-501 and 18-1.3-503 for the particular offense of which the corporation is convicted. For an offense committed on or after July 1, 2003, a business entity shall be subject to the payment of a fine within the presumptive ranges authorized by section 18-1.3-401 (1) (a) (III). An offense committed by a business entity that would be a misdemeanor or petty offense if committed by an individual shall subject the business entity to the payment of a fine within the minimum and maximum fines authorized by sections 18-1.3-501 and 18-1.3-503 for the particular offense of which the business entity is convicted.

18 USC 1091 Genocide:

(a) BASIC OFFENSE.—Whoever, whether in time of peace or in time of war and with the specific intent to destroy, in whole or in **substantial part**, a national, ethnic, racial, or **religious group** as such—

- (1)** kills **members** of that group;
 - (2)** causes serious bodily injury to **members** of that group;
 - (3)** causes the permanent impairment of the mental faculties of **members** of the group through drugs, torture, or similar techniques;
 - (4)** subjects the group to conditions of life that are intended to cause the physical destruction of the group in whole or in part;
 - (5)** imposes measures intended to prevent births within the group; or
 - (6)** transfers by force **children** of the group to another group;
- shall be punished as provided in subsection (b).

(b) PUNISHMENT FOR BASIC OFFENSE.—The punishment for an offense under subsection (a) is—

- (1)** in the case of an offense under subsection (a)(1), where death results, by death or imprisonment for life and a fine of not more than \$1,000,000, or both; and
- (2)** a fine of not more than \$1,000,000 or imprisonment for not more than twenty years, or both, in any other case.

(c) INCITEMENT OFFENSE.—

Whoever directly and publicly **incites** another to violate subsection (a) shall be fined not more than \$500,000 or imprisoned not more than five years, or both.

(d) ATTEMPT AND CONSPIRACY.—

Any person who attempts or conspires to commit an offense under this section shall be punished in the same manner as a person who completes the offense.

(e) JURISDICTION.—There is jurisdiction over the offenses described in subsections (a), (c), and (d) if—

(1) the offense is committed in whole or in part within the United States; or

(2) regardless of where the offense is committed, the alleged offender is—

(A) a national of the United States (as that term is defined in section 101 of the [Immigration and Nationality Act \(8 U.S.C. 1101\)](#));

(B) an alien lawfully admitted for permanent residence in the United States (as that term is defined in section 101 of the [Immigration and Nationality Act \(8 U.S.C. 1101\)](#));

(C) a stateless person whose habitual residence is in the United States; or

(D) present in the United States.

(f) NONAPPLICABILITY OF CERTAIN LIMITATIONS.—

Notwithstanding section 3282, in the case of an offense under this section, an indictment may be found, or information instituted, at any time without limitation.

A suspect in this matter is any person who:

2. Observation of any combination of these effects constitutes evidence that **parties unknown** have acted with malicious intent to cause injury and cause death or permanent disability to peace officers, firefighters, emergency medical service providers, judiciary officers, and the general public and thus have committed crimes of first degree assault and in the cases of death, [murder in the first degree](#);
3. Observation of any of these effects in any combination constitutes evidence that other **parties unknown** have participated in assault or murder lacking intent. These parties unknown have committed [manslaughter](#) or [Reckless Endangerment](#).
4. Other **parties unknown** who coerced other person(s) under threat of economic hardship, accepting an injection as a condition of employment, to accept any injection against their will are guilty of [Criminal Extortion pursuant to 18-3-207](#), a class 4 felony. This statute embodies the universal prohibitions by the threat of economic hardship to subvert informed consent as set forth in the Nuremberg Code:

5. Parties unknown will have intentionally committed one or more the following acts:
 - a. Formulation of disease agents;
 - b. Manufacture carriers of disease agents;
 - c. Distribution of disease agents;
 - d. Administration of disease agents.
